A motion was made by Mark and a second by Amanda to rehire Patty Brown. Motion was passed with Van Brown and Garald Brown abstaining.


A motion was made by Amanda and seconded by Mark to hire Jessica Morman as a 4<sup>th</sup> grade teacher. Motion was passed.
